France's government debt lay at 2,137.6 billion € in the first quarter, up by 40.7 billion in comparison with the previous quarter, announced the National Statistics Institute for Economic Studies (INSEE) on 30th June... Read more

# The UK loses its triple A status



The agencies Standard & Poor's and Fitch downgraded the debt rating of the UK on 27th June from "AAA" to "AA" as they confirmed the choice of the British electorate to leave the EU, with the former justifying their move by the uncertainty generated by the referendum result... Read more

The agency Standard & Poor's downgraded the EU's long term debt rating on 30th June explaining that its decision was based on post-Brexit referendum uncertainty as the UK voted in support of leaving the EU... Read more

Europol indicated on 27th June that 7000 further suspects connected to migrant trafficking had been identified between January and June 2016. Frontex published an analysis on 1st July for the Western Balkans in the first quarter in 2016. The number of illegal border crossings by migrants from Turkey, Greece and Bulgaria dropped by 84% in comparison with the previous guarter to 215,000... Read more

On 28th June the 28 European heads of State and government discussed the result of the UK referendum. They also adopted conclusions on migration, external relations as well as employment, growth and investment... Read more

## UK:

#### New British Prime Minister on 9th September



The name of the successor to British Prime Minister David Cameron will be revealed on 9th September; the candidates declared their intentions on 29th and 30th June. Boris Johnson relinquished the contest. The Conservatives will have to decide between five candidates: Theresa May, Michael Gove, Stephen Crabb, Liam Fox and Andrea Leadsom... Read more

#### Speech by David Cameron at Westminster



The British Prime Minister spoke to parliament on 29th June giving account of the discussions that he held with European leaders the day before. He notably indicated that the latter did not want the UK all of the advantages of membership without certain costs and that this would be "a challenge for the next Prime Minister.".. Read more

#### George Osborne speaks of the referendum

Chancellor of the Exchequer George Osborne spoke on 27th June to announce that following the speech by David Cameron and his decision not to trigger the procedure linked to article 50 immediately he will not launch any emergency measures for the British economy and will wait for the arrival of

a new Prime Minister in the autumn before revising the budget... Read more

## Nicola Sturgeon wants to start preparations for a Scottish referendum



Scottish First Minister Nicola Sturgeon spoke to the Scottish parliament on 28th June to call on Scotland to remain united and for the British government to take a decision following the results of 23rd June. On 29th June she travelled to Brussels to meet the leaders of Europe and to discuss the future of the Scottish situation... Read more
